Primary Care Plan Summary

1. **Plan Description:** Primary Care Plan (Plan) offered by MyPhysicianPlan Inc (MPPI) provides access to a dedicated Primary Care Physician (PCP) during the Plan Term, with the option to visit other PCPs within the MyPhysicianPlan network for routine medical care services.
2. **Policy Rules:**
 - **Plan Term:** Plan term shall be for a minimum period of three months or more as selected by the Member, up to a maximum of 12 months.
 - **Plan Effective Period:** Plan begins from the calendar month and day selected by the Member (Effective Date) and shall remain effective until the end of the Plan Term. Subsequent Plan coverage months shall begin on the same day as the first month of coverage.
 - **Plan Extension:** Member has the option to extend the plan before the original Plan Term ends, adding additional months—up to a maximum total Plan Term of 24 months.
 - **MyPhysicianPlan Notice Period:** Minimum one month prior to the Plan change or cancellation.
 - **Member Notice Period for Plan Cancellation:** Members can cancel the plan before the Plan start date. However, once the Primary Care Plan becomes effective, it is non-refundable and cannot be canceled.
3. **Payment Terms:**
 - **Payment Method:** Debit/Credit Card or any valid digital payment method.
 - **Plan Rate:** \$75/Month
 - **Enrollment Fee:** \$20
 - **PCP Visit Fee (Copay):** \$35 (In-Person Visit) and \$25 (Tele Visit)
 - **Payment Due Date:** Full amount for the selected Plan Term, including the enrollment fee shall be due at the time of enrollment to complete the Member registration and activate the Plan.
 - **Changes to Rates:** All rates are subject to change. Once enrolled and active, however, Plan rates shall remain fixed until the end of the Plan Term.
4. **Plan Features:**
 - **Doctor Visits:** Member shall have unlimited access to both in-person and virtual/telehealth doctor consultations by appointment during the PCP regular office hours. Member shall be responsible for the Copay - \$35 for in person visit and \$25 for tele visit.
 - **Other Services:** ECG or other procedures and tests or vaccinations if required and provided by the Provider shall be paid by the Member at the standard prices offered by the PCP/Provider.
 - **Labs Tests:** Members shall use LabCorp for all tests ordered by the Member PCP. Member shall be billed by MPPI for twenty percent (20%) of LabCorp standard test fees and the amount due shall be charged to the Member's card on file after notifying the Member in advance.
 - **Prescriptions:** Members with the Rx Card can enjoy savings of up to 90% on prescription medications. The actual savings depend on the specific prescription and the pharmacy. Members are responsible for the charges related to their prescription medications.
 - **Free Annual Exam and Lab Tests:** Members with a 12-month plan is eligible for an annual physical exam by the PCP, including lab tests (CBC, CMP, Lipid Profile, and Urinalysis), with no copay. Any additional tests or EKG or other services will be Member responsibility.
 - **Hospitalization, ER, or other providers:** Member Responsibility – directly paid by the Member.
5. **Plan Communication**
 - Plan notifications shall be sent to the Member's registered mobile number/email address.
